

## Privacy Policy

### Privacy Act 1998 (Cth)

### Personal Information

We collect your personal information directly from you when you register your Account or purchase from VIP Charter Vehicles. We do not collect your personal information if you do not register an Account with us. We use your personal information for the following purpose:

We may also use your personal information for a purpose related to promoting Our products to you when:

- we reasonably believe that purpose is directly related to promoting Our products to you;
- and you reasonably expect VIP Charter Vehicles to use or disclose your personal information for a purpose related to promoting our products to you
- they are official partners of VIP Charter Vehicles

We do not disclose your personal information to Merchants. A Merchant may require your personal information directly from you when you seek to redeem a Voucher. We will not disclose your personal information to a third party unless:

- you have consented;
- we are required by law; or
- we are permitted to do so by the National Privacy Principles as set out in the Privacy Act.

We store your personal information securely and in this respect we act in accordance with Principle 4 of the National Privacy Principles as set out in the Privacy Act. You are entitled to access our record of your personal information, except to the extent that we are required or authorised to refuse to provide you with access to that record under the applicable provisions of any law of Australia that provides for access by persons to documents.
